ASAP has conducted recruitment process of Programme Manager trainee under clause 29 of PM pool. The notification for the post Programme Manager trainee was published on 01.11.2018 in the newspaper and the last date of submitting application was on 14.11.2018. Total 894 candidates were applied for the post and the candidates preliminary screening NAC- F test was conducted on 9.12.2018 at 22 Skill Development Centers of ASAP. In the NAC test, 191 out of 894 candidates, who scored 60% and above (part A and part B) were qualified for the Case study presentation round. The qualified candidates attended the case study presentation and it was conducted on 17th, 18th and 19th of February 2019 at ASAP. The candidates who scored 60% and above mark qualified for the final Interview round and total 79 candidates were shortlisted for the interview. Based on the interview conducted for the post of Programme Manager Trainee on 18-02-2019, 19-02-2019 & 21-02-2019 at MASCOT hotel Trivandrum, the following candidates are provisionally qualified for the post of the Programme Manager Trainee.
